# MATERNAL OCCUPATIONAL EXPOSURE TO ORGANIC SOLVENTS AND INTRAUTERINE GROWTH IN THE ELFE COHORT

## Highlights:

- Petroleum and oxygenated solvents were associated with a higher risk of SGA.
- Oxygenated and chlorinated solvents were linked to a smaller head circumference.
- Third trimester solvent exposure seemed to affect fetal growth most.

# **ABSTRACT**

**Background:** In developed countries, about 15% of women are occupationally exposed to solvents. Associations between this maternal occupational exposure and intrauterine fetal growth are inconsistent, but almost no existing study has investigated this relation by solvent family (oxygenated, petroleum, and chlorinated), although they may affect fetal growth differently.

**Objectives:** To investigate the relations between maternal occupational solvent exposure, by solvent family, and the risk of neonates born small for gestational age (SGA), or with low birthweight, or with small head circumference (HC).

**Methods**: Among the 18,040 women included in the Elfe birth cohort, we included 13026 women who worked during pregnancy (72% of the cohort). Information about maternal occupations and industrial activities during pregnancy was collected by questionnaire at the maternity ward, and completed at 2-month when necessary. Using Matgéné job-exposure matrices, we assessed maternal occupational exposure to solvents. Logistic and multiple linear regressions were used to assess the association between maternal occupational solvent exposure and SGA status, birth weight, and HC. Analyses were conducted for exposure during pregnancy and also stratified by the trimester that pregnancy leave began.

**Results**: We observed a higher risk of SGA newborns among mothers occupationally exposed during pregnancy to petroleum solvents ( $OR_{adjusted} = 1.26$ ; 95%CI: 1.01 to 1.57). Among women working until the third trimester of pregnancy, we observed a higher risk of SGA newborns to those occupationally exposed to oxygenated solvents ( $OR_{adjusted} = 1.75$ ; 95%CI: 1.11 to 2.75), a significantly lower birthweight for infants of mothers exposed to petroleum solvents ( $\beta_{adjusted} = -47.37$  g; -89.33 to -5.42), and a lower HC among newborns of those occupationally exposed to oxygenated solvents ( $\beta_{adjusted} = -0.28$ ; -0.49 to -0.07) and to chlorinated solvents ( $\beta_{adjusted} = -0.29$ ; -0.53 to -0.05).

**Discussion:** Our results suggest that maternal occupational solvent exposure may influence fetal growth, especially exposure into the third trimester of pregnancy.

# 1. INTRODUCTION

2 In developed countries, most women work during pregnancy (Casas et al., 2015; "Enquête nationale périnatale," 2016; "Maternity Leave and Employment Patterns of First-Time Mothers: 1961-2008," 3 4 2011). For example in France, 70.8% of women included in the 2016 French perinatal survey did 5 ("Enquête nationale périnatale," 2016), as well as 65.6% of those included in the 2008 Panel of the 6 U.S. Census Bureau's Survey of Income and Program Participation ("Maternity Leave and 7 Employment Patterns of First-Time Mothers: 1961-2008"). During the first decade of this century, 8 14.7% of women workers were occupationally exposed to solvents (Pilorget et al., 2017), defined as 9 liquids with the property of dissolving, diluting, or extracting other substances without causing 10 chemical modification of either those substances or themselves. These chemicals are present in a wide range of products, such as adhesives, paints, dyes, inks, cleaning products, and cosmetics. Solvents are 11 12 classified into 3 major chemical families: oxygenated solvents (e.g., alcohols, esters, and ketones), 13 petroleum solvents (e.g., benzene, aliphatic solvents, and aromatic solvents), and chlorinated solvents 14 (e.g., perchloroethylene and trichloroethylene). Many of these can cross the placental barrier (Donald et al., 1991; Elkin et al., 2020; Loch-Caruso et al., 2019; Ungváry and Tátrai, 1985). 15

Small for gestational age (SGA) newborns are an important public health concern, because they are at higher risk of various immediate-, mid-, and long-term postnatal complications, including metabolic, immune, neurologic, respiratory, and endocrine adverse outcomes (Kesavan and Devaskar, 2019; Mayer and Joseph, 2013). The relation of maternal occupational solvent exposure to SGA status has thus far been explored in 6 studies (Ahmed and Jaakkola, 2007; Lipscomb et al., 1991; Desrosiers et al., 2015; Seidler et al., 1999; Shirangi et al., 2020; Zhu et al., 2006) and that to birthweight in 10 studies (Ish et al., 2022; Desrosiers et al., 2015; Burdorf et al., 2011; Snijder et al., 2012; Ahmed and Jaakkola, 2007; Ronda et al., 2010; Axelsson et al., 1984; Khattak et al., 1999; Ha et al., 2002; Vaktskjold et al., 2014). Two of these studies reported a significantly higher risk of SGA status (Ahmed and Jaakkola, 2007; Lipscomb et al., 1991), and three observed a significantly lower birth weight (Khattak et al., 1999; Vaktskjold et al., 2014; Ha et al., 2002), but the others did not report significant associations. Among the reasons that may explain these inconsistent results, we note the lack of power in some studies, their different assessment methods (job-exposure matrices, expertise, or self-report), and the heterogenous definitions of solvents in most studies, without any investigation of these potential associations by solvent family, although these families may have different effects on fetal growth. Accordingly, among the 10 studies that investigated the impact of maternal occupational exposure to solvents in the general population (Ahmed and Jaakkola, 2007; Burdorf et al., 2011; Ish et al., 2022; Khattak et al., 1999; Seidler et al., 1999; Shirangi et al., 2020; Snijder et al., 2012; Vaktskjold et al., 2014; Zhu et al., 2006; Desrosiers et al., 2015), nine explored the relation with solvents as a single group. Only the study by Desrosiers et al. investigated these relations separately

- 36 for petroleum and chlorinated solvents (Desrosiers et al., 2015). It found a higher but not
- 37 statistically significant risk of SGA status. Unfortunately, this study did not consider oxygenated
- 38 solvents, although it is the most frequent family (Pilorget et al., 2017).
- 39 In addition to SGA status and birthweight, measurement of head circumference (HC) at birth is
- 40 another fetal growth parameter of particular interest as it is regularly used as a proxy for brain volume
- 41 and intrauterine brain development (Barbier et al., 2013). In addition, several publications have shown
- 42 positive associations between HC and cognitive function, long-term memory storage and retrieval, and
- visuospatial ability (Gale et al., 2006; Veena et al., 2010). To the best of our knowledge, only one
- study (Snijder et al., 2012) has investigated the relation between HC and maternal occupational
- exposure to solvents; it did not distinguish solvent families and did not report any associations.
- While pregnant women remain frequently exposed to organic solvents at work, the question
- 47 concerning their impact on fetal growth is still debated, especially in view of the lack of data by
- solvent family, as these different families may have different effects. Using data from a large sample
- 49 of newborns from the French ELFE cohort, we aimed to assess the influence of occupational exposure
- to oxygenated, petroleum, and chlorinated solvents on SGA status, birthweight, and HC.

# 2. MATERIALS AND METHODS

- 53 ELFE ("Etude Longitudinale Française depuis l'Enfance") is a French nationwide birth cohort
- 54 intended to explore the influence of environmental and socioeconomic contexts on children's health
- and development from birth to the age of 20 years. The ELFE cohort has previously been described in
- 56 detail (Charles et al., 2019).

- 57 Overall, 349 maternity departments were randomly selected among the 544 with more than one
- delivery per day in mainland France, and 320 of these agreed to participate in recruiting the ELFE
- 59 cohort. Women aged 18 years or older who gave birth to liveborn singletons or twins after 33 weeks of
- 60 gestation were included in the study. Four inclusion periods occurred in 2011: April 1–4, June 27–July
- 4, September 27–October 4, and November 28–December 5. Written informed consent was required to
- participate, and women had to state that they did not plan to leave mainland France for the next three
- 63 years. Overall, 51% (18,040 women with 18,329 newborns) agreed to participate in the cohort during
- 64 their stay in the maternity ward. Because 55 families subsequently requested the destruction of their
- data, 18,274 children were finally included in the ELFE cohort follow-up.
- The population of this study excludes multiple pregnancies (n=287 twin pregnancies/574 children),
- 67 major malformations as defined by the European surveillance of congenital anomalies ("European
- 68 Platform on Rare Disease Registration," 2014) (n=303 children), and mothers who did not work
- during their pregnancies (n=4159 women). The study thus finally includes 13,238 mother-child pairs
- 70 (Figure 1).

## 2.2 Data collection

- 72 During the maternity unit stay, trained midwives collected participants' sociodemographic,
- 73 socioeconomic, and medical characteristics in face-to-face interviews and data about their
- 74 pregnancies, deliveries, and medical histories from their medical records. Two months after childbirth,
- parents were asked to complete an email questionnaire about social and medical data. More details are

- Each data collection received the necessary approvals from the French Consultative Committee for the
- 78 Treatment of Information in Medical Research (n°10.623), the French National Commission for the
- 79 Confidentiality of Computerized Data (n°910504), and the Committee for the Protection of Persons
- 80 Participating in Biomedical Research (n°CPP-IDF IX-11-024).

# 2.3 Maternal occupational exposure to solvents

Information about maternal occupations and industrial activities was initially collected at the maternity ward and completed with the 2-month questionnaire when necessary. One single expert was in charge of occupational coding for all women, according the job title and the industry but also using tasks descriptions and type of contract (self-employment, employees...). The coding was made blind to the maternal and child health status, using standardized procedures (hierarchization of information used for coding and validation of homogeneity of coding with occupation and industrial activity) to limit classification bias. Maternal occupations were coded according to the International Standard Classification of Occupations from 1968 (ISCO 1968) (ISCO-International Standard Classification of Occupations, 1968) and the French classification of professions and socioprofessional categories from 1994 (French PCS 1994) ("Nomenclatures des professions et catégories socioprofessionnelles | Insee," 1994). Industry activities were coded with the International Standard Industrial Classification of All Economic Activities from 1975 (ISIC 1975 classification) ("International Standard Industrial Classification of All Economic Activities," 1975) and the French classification of economic activities from 2003 (French NAF 2003) (INSEE, 2003). French National Public Health Agency (Santé Publique France) conducted the Matgéné project, resulting in developing three job-exposure matrices (JEMs), focusing respectively on oxygenated, petroleum, and chlorinated solvents (Févotte et al., 2011). These JEMs also assessed exposures to subgroups of solvents within each family: alcohols, ketones and esters, ethylene glycol, diethyl ether and tetrahydrofuran for oxygenated solvents; benzene, fuel oil, industrial spirit, kerosene (lighting oil), diesel and fuel oils, white spirit and other light aromatic cuts for petroleum solvents; chloroform, methylene chloride, perchloroethylene, trichloroethylene; and 1,1,1-trichloroethane for chlorinated solvents. Exposures to each family or subgroup of were defined by a probability (per class of 10% for oxygenated and chlorinated solvents; 0%, 10%, 50%, 90%, and 100% for petroleum solvents) and level of exposure (very low, low, moderate, and high for oxygenated and chlorinated solvents; low, moderate, and high for petroleum solvents). These parameters are presented in the supplemental materials (Table S1).

Due to missing or imprecise data about maternal occupation or industrial activities, exposure assessment could not be performed for 212 women; 13,026 mothers had complete assessments. When mothers reported multiple jobs during pregnancy (n=15), we consider only the job with the highest level of exposure.

Before starting the main analysis, we recoded maternal occupational exposure to solvents according to the distribution of the exposure probability of each solvent family in our study population. Maternal occupational exposure to oxygenated solvents was classified according to probability of exposure: not exposed, likely exposed (probability below 90%) and certainly exposed (probability >90%). For women certainly exposed, we differentiated those exposed at a very low level from those exposed at

least at a low level of intensity. The small numbers of combinations for maternal occupational exposures to petroleum and chlorinated solvents led us to group the JEM exposure assessments in two categories: not exposed and possibly exposed (any probability, any level) (Tables S2-S4).

# 2.4 Anthropometric parameters and small-for-gestational-age assessment

Birthweight and head circumference at birth were recorded in the medical files. SGA was defined as a birthweight under the 10<sup>th</sup> percentile for gestational age and sex in France, by using the EPOPé charts (Ego et al., 2016). Among the 13,026 children for whom occupational exposure was assessed, SGA status was assessed for 12,676 (97.3%), while 12,756 newborns had information available for birthweight (97.9%) and 11,676 for head circumference (89.6%) (Figure 1).

# 2.5 Statistical analysis

- We reviewed the relevant literature to develop a directed acyclic graph (DAG) (Shrier and Platt, 2008), which was used to determine the minimally sufficient adjustment sets of variables for regression models to prevent for confounding and estimate the total effects of the studied exposure on the outcome (Figure S1). Based on this DAG, our models were systematically adjusted for maternal education level (primary and secondary education, passing baccalaureate, university level), smoking status (nonsmoker, stopped smoking during pregnancy, smoker), alcohol consumption during pregnancy (no, yes), and maternal body mass index (BMI<18.5 kg/m², 18.5 kg/m²  $\leq$  BMI <25 kg/m², <25kg/m²  $\leq$  BMI <30 kg/m², BMI  $\geq$ 30 kg/m²). Statistical models for birthweight and head circumference were additionally adjusted for gestational age (in weeks of gestation; linear and quadratic form) and the newborn's sex.
- Due to the small numbers of missing values for covariables, we imputed missing values by the mode:
- maternal education level (baccalaureate; n=43, 0.3%), smoking status (nonsmoker; n=141, 1.1%),
- alcohol consumption during pregnancy (none; n=60, 0.5%), and maternal body mass index (18.5)
- 139  $kg/m^2 \le BMI < 25 kg/m^2$ ; n=179, 1.4%).
- We first studied the relation between each outcome and each maternal occupational exposure to each
- solvent family (oxygenated, petroleum, and chlorinated solvents) individually. In addition, if several
- exposures were significantly associated with the same outcome, mutual adjustments were performed
- in a subsequent analysis. We also performed analyses stratified by when mothers stopped working: in
- the first, second, or third trimester of pregnancy.
- We used logistic regression to study associations with SGA status and multiple linear regression to
- study association with birthweight and HC. Results are presented as odds ratios (ORs) and beta
- 147 coefficients with their 95% confidence intervals (95%CI).

148	Three sensitivity analyses were performed to test the robustness of our results: 1) we changed the
149	threshold for considering women to be certainly exposed to oxygenated solvents (probability of
150	exposure above 50% rather than the 90% applied in the main analyses); 2) we aggregated women
151	certainly exposed to oxygenated solvents at very low level and at a low level; and 3) we further
152	adjusted the models studying HC for mode of delivery.

153 A p-value <0.05 was defined as statistically significant. SAS 9.4 and R version 3.6.2 were used for statistical analyses.

Table 1 describes the study population. The participants' mean age was  $31 \pm 5.0$  years. Almost two-thirds of them had attended at least some university (65.6%), 16.9% were overweight, and 8.2% obese; 16.9% smoked, and 19.6% had drunk alcohol during their pregnancy. Boys accounted for 51% of the newborns. On average, children were born at 39 weeks of gestation, weighed 3340 g  $\pm$  469 g and had a HC of 34.4 cm  $\pm$  1.4 cm at birth. Overall, 9.7% of newborns were SGA and 4% preterm. Half the women stopped working during their third trimester of pregnancy (n=6968, 52.6%), 28.9% (n=3825) during the second trimester, and 8.1% (n=1071) during the first. This information was unavailable for 10.4% of our population (n=1374).

# 3.2 Maternal occupational exposure to solvents

- The mothers of children included in this analysis were employed mainly as clerical (n=3141; 24.1%),
- service (n=2203; 16.9%), and sales (n=1439; 11.0%) workers, as well as teachers (n=1426; 10.9%)
- 169 (Table 2).
- In all, 885 (6.9%) of the women included in this analysis were likely and 2037 (15.8%) certainly occupationally exposed during pregnancy to oxygenated solvents (Table 2). Among the certainly exposed women, 1785 (13.8% of those included in this analysis) were exposed at a very low level and 252 (2.0%) at least at a low level (Table S2). Mothers occupationally likely exposed to oxygenated solvents were mainly cleaners and helpers (70.0%) (Table 2). Those certainly exposed at a very low level were primarily health-related professionals (91.3%) and hairdressers (8.6 %), and those certainly
- exposed to at least a low level were chemists (49.6%) and hairdressers (32.9%) (Table 2). Alcohols
- were the most frequent subclass of oxygenated solvents in our study (6.3% of women were classified
- as likely exposed and 14.9% as certainly exposed), ahead of diethyl ether (13.4% as likely exposed,
- and none as certainly exposed), and ketones and esters (1.5% likely exposed and 1.3% certainly
- 180 exposed) (Table S5).
- For petroleum solvents, 861 women were classified as possibly occupationally exposed (6.7%),
- mainly at a low or very low level (n=858, 6.6%) (Table S4). Jobs mainly classified as possibly
- exposed to petroleum solvents were cleaners (60.2%) and chemists (17.7%). White spirit was the most
- 184 frequent petroleum solvent exposure in our study (5.9% of the women were classified as possibly
- exposed) followed by special essence (1.6%) (Table S5).
- 186 Regarding chlorinated solvents, 190 women (1.5%) were classified as possibly occupationally
- exposed, at a low or very low level (Table S4). Mothers possibly occupationally exposed to
- chlorinated solvents were mostly chemists (83.2%) (Table 2). The most frequent chlorinated solvent

exposures involved dichloromethane and trichloromethane (1.3% of women for both chemicals)

(Table S5).

# 3.3 Maternal occupational solvent exposure and intrauterine fetal growth

- We observed a nonsignificantly higher risk of SGA status among children of mothers likely exposed to oxygenated solvents ( $OR_{adjusted} = 1.24$ ; 0.99 to 1.55) but not for children of mothers who were certainly exposed (certainly exposed at a very low level:  $OR_{adjusted} = 1.01$ ; 0.85 to 1.20; certainly exposed at least at a low level:  $OR_{adjusted} = 1.28$ ; 0.86 to 1.90) (Table 3). The risk of an SGA newborn was statistically significantly higher among mothers who were occupationally exposed to petroleum solvents ( $OR_{adjusted} = 1.26$ ; 1.01 to 1.57), but the association was not statistically significant for maternal exposure to chlorinated solvents ( $OR_{adjusted} = 1.31$ ; 0.83 to 2.06) (Table 3). A significant excess risk for a SAG newborn appeared for women certainly exposed at least at a low level to oxygenated solvents who worked into the third trimester ( $OR_{adjusted} = 1.75$ ; 1.11 to 2.75) (Table 4). The estimates for exposure to petroleum solvents, although not significant, were in the same range as for the main analyses when stratifying for trimester of starting maternity leave (during the first or second trimester:  $OR_{adjusted} = 1.34$ ; 0.96 to 1.89; third trimester:  $OR_{adjusted} = 1.20$ ; 0.85 to 1.72) (Table 4).
- No statistically significant associations were observed between maternal occupational exposure to oxygenated, petroleum, or chlorinated solvents and birthweight as a continuous variable (Table 3).
- When trimester of maternal leave during pregnancy was considered, birthweight was significantly
- lower in the children of mother exposed to petroleum solvents who worked into the third trimester
- 208 ( $\beta_{adjusted} = -47.37g$ ; -89.33 to -5.42) (Table 4).
- 209 HC was lower among children of mothers certainly exposed to at least a low level of oxygenated
- solvents ( $\beta_{\text{adjusted}} = -0.27$ ; -0.44 to -0.10) (Table 3) or exposed to chlorinated solvents ( $\beta_{\text{adjusted}} = -0.25$ ; -
- 211 0.44 to -0.06) (Table 3). The association between petroleum solvents and HC was not statistically
- significant ( $\beta_{\text{adjusted}} = -0.05$ ; -0.15 to 0.04) (Table 3). After mutual adjustment for exposure to
- 213 oxygenated and chlorinated solvents, oxygenated solvent exposure to at least a low level remained
- statistically significant ( $\beta_{adjusted} = -0.25$ ; -0.47 to -0.03), but chlorinated solvent exposure was not
- $(\beta_{adjusted} = -0.07; -0.32 \text{ to } 0.18)$  (Table 5). HC was lower among the children of mothers certainly
- exposed to at least a low level of oxygenated solvents ( $\beta_{adjusted} = -0.28$ ; -0.49 to -0.07) or exposed to
- chlorinated solvents ( $\beta_{adjusted} = -0.29$ ; -0.53 to -0.05) for those mothers who worked into the third
- 218 trimester (Table 4). These associations were not observed, however, when women stopped working
- during the first or second trimester of pregnancy (certainly exposed to oxygenated solvents at least at a
- low level:  $\beta_{adjusted} = -0.16$ ; -0.50 to 0.18; exposure to chlorinated solvents:  $\beta_{adjusted} = -0.19$ ; -0.55 to

# 4. DISCUSSION

We report an increased risk of SGA newborn among mothers occupationally exposed during pregnancy to petroleum solvents, as well as among women who were occupationally exposed to oxygenated solvents at least at a low level and who worked into their third trimester of pregnancy. For birthweight as a continuous variable, a significantly lower birthweight was observed only for infants of mothers still working during the third trimester and exposed to petroleum solvents; no risk was observed for other solvents or other time periods. Finally, HC was lower among the children of mothers occupationally exposed to oxygenated or chlorinated solvents, especially those working into their third trimester. Our results remained stable in sensitivity analyses.

Our search found only one study that previously investigated the relation between maternal occupational exposure by solvent families and the risk of SGA status. Desrosiers et al. analyzed data from 2886 mothers and their infants born between 1997 and 2002 in the USA. In this study, industrial hygienists assessed the probabilities of exposure to ten organic solvents: six chlorinated, three aromatic and the petroleum-based mixture Stoddard solvents (also known as mineral spirits or white spirits), and SGA was defined as in our study as birthweight below the 10th centile for a given gestational age at delivery. They found a higher but not statistically significant risk of an SGA neonate when mothers were occupationally exposed to any solvents (OR=1.71; 95%CI: 0.86-3.40), chlorinated solvents (OR=1.70; 95%CI: 0.69-4.01), and aromatic solvents (OR=1.87; 95%CI: 0.78-4.50) but not with Stoddard solvent (OR=0.98; 95%CI: 0.44-2.18) (Desrosiers et al., 2015). This absence of statistical significance might be due to a lack of power (only 23 women (10.1%) with an SGA newborn were exposed to any solvent, 18 (7.9%) to chlorinated solvents, and 7 (3.1%) to aromatic solvents). These studies are partially consistent with our results for aromatic solvents but not for Stoddard solvents, which were the most frequent subclass of petroleum solvent in our study. In addition, Desrosiers et al. did not examine either occupational exposure to oxygenated solvents or the influence of the trimester when pregnancy leave began.

We also highlighted lower birthweight in the newborns of women exposed to petroleum solvents into the third trimester, in line with the study by Ha et al. (Ha et al., 2002). They investigated the association between birthweight and maternal and paternal exposure to organic solvents in 1222 couples employed in a large petrochemical corporation in Beijing, China (Ha et al., 2002). In this study, a trained interviewer assessed parental exposures to organic solvents considering only four petroleum solvents in their definition of organic solvents (benzene, toluene, xylene, and styrene). The authors concluded that maternal exposure to organic solvents is significantly associated with a lower birthweight (-81.7g, 95%CI: -106.3 to -3.1) (Ha et al., 2002).

Only one previous epidemiological study investigated the relation between maternal occupational exposure to solvents and newborn HC (Snijder et al., 2012), analyzing data from 4680 pregnant women participating in the Generation R cohort study from early pregnancy onwards in the Netherlands (2002–2006) (Snijder et al., 2012). Using the JEM developed by Brouwers et al. (Brouwers et al., 2009), Snijder et al. estimated maternal occupational exposure to potential endocrine-disrupting chemicals that included an organic solvent category based on exposure to 6 organic solvents (ethylene glycol ethers, styrene, toluene, xylene, trichloroethylene, and perchloroethylene) but not on most oxygenated and chlorinated solvents. They observed no significant reduction in HC when mothers were exposed to organic solvents (221 pregnant women (4.7%) exposed,  $\beta_{adjusted}$ : -0.00902, standard error: 0.00560, with the *p*-value and 95%CI not provided). No study has focused on a broader definition of organic solvents including oxygenated solvents, although it is the most frequent solvent family involved in occupational exposure (Garlantézec et al., 2012).

Our results about the impact of oxygenated and petroleum solvents on fetal growth are also consistent with animal studies that have reported associations with several alcohols (ethanol, methanol, propanol, glycol, etc.) (Nelson et al., 1990) and with white spirit (Carrillo et al., 2014), which respectively accounted for the vast majority of oxygenated and petroleum solvent exposures in our study. We think that these solvents might be deleterious at three different levels — at the maternal, placental, or directly at the fetal level, since many solvents can cross the placental barrier (Donald et al., 1991; Elkin et al., 2020; Loch-Caruso et al., 2019; Ungváry and Tátrai, 1985). We have found no evidence that the different solvent families use common mechanisms; we have thus considered these exposures separately. The underlying mechanisms have rarely been investigated except for that of ethanol, which accounts for half of the oxygenated solvents used in France (INRS, 2009). Nelson summarized 13 alcohols administered by inhalation to rats (Nelson et al., 1990), whereas other studies about fetal consequences of alcohol used ingestion models that correspond to the most common nonoccupational maternal exposure during pregnancy. Thus, ethanol ingestion has been reported to affect maternal levels of iron and zinc, creating maternal deficiencies (Naik et al., 2022) that can result in fetal growth restriction by reducing levels of insulin-like growth factor-1 and its receptor activity (Naik et al., 2022). It also affects placental stress response (Gårdebjer et al., 2014) and disrupts trophoblast angiogenic factors (Gualdoni et al., 2021). Trichloroethylene ingestion (chlorinated solvent), on the other hand, increases placental oxidative stress markers in a rat model of fetal growth restriction (Loch-Caruso et al., 2019).

The effects observed with reduced HC are also in accordance with what is known of the neurotoxicity of several alcohols (Nelson et al., 1990) and tricholoromethane (Agency for Toxic Substances and Disease Registry, 1997). The effects observed in our study were broader for exposures lasting into the third trimester. In humans, intrauterine fetal growth is quite slow until the 23rd week of gestation, and

then accelerates before peaking around the 34th week (Lepercq and Boileau, 2005). We can thus hypothesize that impairments during the period of fetal growth might have a greater impact on anthropometric parameters at birth. Solvent exposure in late gestation has been shown to cause greater effects in animal studies (Donald et al., 1991).

We used data from a large birth cohort (n= 13,026 women) with detailed information about a wide range of personal and medical characteristics that allowed us to control for various potential confounders (Charles et al., 2019). Including only women who worked during their pregnancy enabled us to avoid bias from the "healthy worker effect," since women who were not working might have a higher rate of adverse pregnancy outcomes (Casas et al., 2015). However, we have no data on possible sick leave during pregnancy (we only have the beginning of the maternity leave). Nonetheless, the population selection strategies might have led to some limitations. In particular, the ELFE cohort only included women who gave birth after 33 weeks of gestation, which might have resulted in excluding some premature newborns with severe SGA.

The JEMs we used to assess solvent exposure were developed for the general population in France by the French Institute for Public Health Surveillance during the same period as the ELFE pregnancies (Févotte et al., 2011). Exposure misclassification is likely when using JEMs (Vaktskjold et al., 2014). Most authors investigating the properties of generic JEMs have emphasized that they could plausibly underestimate variability in exposures, since the same probability and levels of exposure are allocated for a given combination (occupation and industrial sector) without considering between-worker variability (for specific tasks, material use, work environments, period or use of different protection devices) (Fritschi, 2019; Ge et al., 2018; Teschke et al., 2002). By assigning the mean exposure level to the whole group, JEMs induce Berkson-type misclassification error, which tends to reduce study power, but leads to little or no bias in the estimators of logistic or linear regression coefficients (Armstrong, 1998).

Another limitation is that the low number of women classified as exposed to petroleum and chlorinated solvents in our study were not sufficient to benefit from the fine level of exposure probability and intensity available in the JEMs. Grouping together various types, probabilities, and intensities of exposure might have diluted possible associations (Teschke et al., 2002). Finally, we could not rule out the possibility that associations observed in our study might be markers of association with other co-exposures that we did not evaluate study rather than the direct effect of solvents.

Among our neonatal outcomes, we defined SGA with the French EPOPé unadjusted intrauterine fetal growth charts, developed from the 2010 French Perinatal Survey (FPS). An alternative would have been to use customized charts that include in addition maternal characteristics (height, weight, parity)

associated with fetal weight that better consider each infant's intrinsic growth potential (Mamelle et al., 2006). However, these main variables were included in our adjustment strategy. Another key point in studying fetal growth is to date the pregnancy accurately. The American College of Obstetricians and Gynecologists, the American Institute of Ultrasound in Medicine, the Society for Maternal-Fetal Medicine and the French College of Fetal Echography recommend the use of the craniocaudal length measurement performed during the usual first trimester screening ultrasound ("Collège Français d'Échographie Fœtale," 2022; The American College of Obstetricians and Gynecologists, 2014), as performed in ELFE cohort. But the inaccuracy of this method is ± 5-7 days (Obstetrics & Gynecology, 2017). Estimates based on menstrual dates are two to three days higher, on average, than those based on early ultrasound, a difference usually attributed to late ovulation (Morin et al., 2005). Nevertheless, the difference between the date of the last menstrual period and the ultrasound dating has been reported to be a marker of the risk of early growth restriction (Källén, 2004; Morin et al., 2005). Thus, we cannot exclude the possibility that occupational exposure to solvents is responsible for early SGA status and that sonographic correction could have underestimated this effect. Other studies have used fetal growth trajectories based on ultrasound-estimated fetal growth to study SGA status (Snijder et al., 2012). Their method let them differentiate intrauterine growth retardation that occurred in the second or in the third trimester of pregnancy. But it also resulted in selective participation, with mothers with lower socioeconomic status less well represented and required suitable reference charts for fetal growth (Snijder et al., 2012).

We planned in advance to adjust for potential confounders based on a directed acyclic graph, constructing an a priori model of the postulated relations between the maternal occupational solvent exposures, intrauterine growth, and the covariates (Shrier and Platt, 2008) to enable theoretically and expert-based adjustment of sets of covariates. Moreover, in sensitivity analyses, we additionally chose to adjust the models studying HC for the mode of delivery to consider plastic deformation of the fetal head; after vaginal delivery, newborn heads can have a "sugar loaf" appearance because of its increased length and the reduction in its 2 largest dimensions (biparietal and suboccipito-bregmatic) (Schaal, 2012). Babies born by cesarean section will have a rather round head. We also performed two other sensitivity analyses: changing the threshold to consider women as certainly exposed to oxygenated solvent at a probability of exposure above 50% rather than the 90% in the main analyses, and aggregating women certainly exposed to oxygenated solvent at very low and low levels. These results were consistent with the main analyses.

# 5. CONCLUSION

Our study based on job-exposure matrices highlighted an increased risk of SGA newborns when mothers were occupationally exposed to petroleum and oxygenated solvents. We also observed lower HC when mothers were occupationally exposed to oxygenated or chlorinated solvents. These results were strongest among women who worked into the third trimester of pregnancy. Other studies need to be conducted on this topic to confirm these results and investigate potential co-exposures in the workplace. If these results are confirmed, preventive measures should be reinforced for pregnant women occupationally exposed to solvents especially if they work into their third trimester of pregnancy.




